ABOUT THE AWARDS

The Women of Distinction Awards presented by Scotiabank is YWCA Metro Vancouver's premier fundraising event. The Women of Distinction Awards honours self-identifying women whose outstanding achievements contribute to the well-being and future of our community. The Awards also honours businesses and organizations that support the wellness and diverse needs of their employees.

HOW TO NOMINATE

All nominations must be completed and submitted online.

We recommend you have all documents ready before completing the online nomination. A nominator must complete all required fields on the online nomination form, including:

- Nominee and nominator information
- Summary of nomination (120 word maximum)
- Nomination criteria (300 word maximum for each of the criteria)
- Letters of support (three letters required from third parties to the nomination)
- Optional: supplemental materials (magazine ads, media releases etc., resumes, three pages maximum)
- Submit the online nomination form and email all additional material

Deadline: Friday, December 1, 2023 at 5:00pm.



ELIGIBLE NOMINEES MUST:

- 1. Live and work (individuals) or operate (businesses and organizations) within the Metro Vancouver region bounded by and including Hope, Pemberton, Sunshine Coast and the United States border.
- 2. Not currently be in a campaign for or serving a term in office as an elected government official.
- 3. Satisfy each of the five nomination criteria for their award category as listed below.
- 4. Consent to the nomination and the publication of their name, photo and information.
- 5. Attend the photo shoot on either Wednesday, February 14 or Thursday, February 15, 2024.
- 6. Attend the Announcing the Nominees' reception (date TBC, March 2024) and Awards reception and dinner on May 13, 2024.
- 7. Be 18-25 years of age as of March 8, 2024, for the Young Woman of Distinction category.
- 8. Satisfy the YWCA Metro Vancouver Women of Distinction Values Statement.
- 9. Submit a quote and participate in the Connecting the Community Award (individual nominees only).



NOMINEES CRITERIA - INDIVIDUALS


A Woman of Distinction inspires others. They have achieved outstanding success in their field by:

- 1. Showing vision and initiative to break new ground or old barriers.
- 2. Demonstrating accomplishments that help them stand out amongst their peers.
- 3. Being a leader and role model.
- 4. Participating actively as a volunteer.
- 5. Being recognized by their community for their sustained commitment and contribution within their category.

NOMINEES CRITERIA - OUTSTANDING WORKPLACE

An Outstanding Workplace supports the wellness and diverse needs of its employees by:

- 1. Being a role model in best workplace practices and implementing an innovative initiative exclusively for employees.
- 2. Being progressive and responsive to employee needs, including work/life balance.
- 3. Being committed to Equity, Diversity and Inclusion.
- 4. Supporting the advancement and success of women.
- 5. Fostering professional development and mentorship.
- 6. Supporting employee volunteerism and community initiatives.
- 7. Promoting healthy lifestyles.



HOW ARE THE NOMINEES AND RECIPIENTS CHOSEN?

The nominations committee reviews all submissions for completeness and eligibility. Accepted nominations are forwarded to an independent judging panel. The nominations committee and judging panel reserve the right to withhold an award in any category. All nominees will be advised of the eligibility of their applications by Wednesday, February 1, 2024.

HOW ARE THE NOMINEES RECOGNIZED?

All qualified Nominees will be officially and publically announced at the Announcing the Nominees Celebration in Honour of International Women's Day (date TBD, March 2024). All Nominees and award recipients will be honoured at the Awards reception and dinner on May 13, 2024. Award recipients are announced at the dinner. Regular tickets for guests will be available online at ywcawomenofdistinction.org on February 1, 2024.

CONNECTING THE COMMUNITY AWARD

(INDIVIDUALS ONLY)



All individual nominees are eligible for the Connecting the Community Award. It is the only award determined by an online vote. Each nominee chooses a pre-defined YWCA program area to support:

- Advance gender equity
- Support early learning and child care
- Deliver affordable housing for single mother-led families
- Support access to justice
- End gender-based violence

The online vote will be open March 8 – April 12, 2024. Nominees are encouraged to use social media to promote their choices and generate votes. The nominee with the most votes will receive the Connecting the Community Award and Scotiabank will donate \$10,000 to the YWCA program area of her choice.

AWARDS CATEGORIES

ARTS, CULTURE & DESIGN

The YWCA reserves the right to revoke an award if subsequent circumstances respecting the recipient contradict the mission, ethics and / or values of YWCA Metro Vancouver or bring its reputation in into disrepute. The nominee or nominator may withdraw the nomination, for any reason, up to two weeks before the Award ceremony. The withdrawal must be made in writing, notifying the nominator/nominee and the YWCA of the withdrawal. The YWCA will accept the withdrawal, effective immediately. We strongly encourage nominations that recognize the contributions of Black, Indigenous and People of Colour, as well as 2SLGBTQIA+ individuals.


